Call Meeting to Order: Meeting was called to order at 6:30 pm by Mayor Bartsch. The Pledge of Allegiance was recited.

1. **Hearing of Appeal** Mayor Bartsch explained the purpose of the hearing was to hear the appeal of the imposed fine of \$50.00 for the violation citation of section 152.296; not obtaining a zoning permit. Daniel Petsinger handed the council the two documents he received. The public notice posting sent on August 12th and the letter of notification sent on August 20th. He pointed out that the stated violation did not match on the two documents. The first one identified the hearing purpose as 152.296, zoning permits required. The letter of notification stated 152.296 failure to obtain a building permit. After consideration by the council, the fine hearing was rescheduled to 6:30 pm, September 12th.

A motion was made by Council Member Froman to adjourn the Council Meeting. Council Member Bartness advanced.

Motion carried, all in favor. The meeting was adjourned at 6:43 pm.




